Once they gave in, she then begged for another dog, at that time her parents put their foot down. They told her, "When you get married and have your own house, you can have as many dogs as you want." Well she took that to heart and began volunteering and fostering for various rescues in the area. That is until she made her dream a reality and formed Magnificent Mutts Rescue.

We are a group of dedicated volunteers who provide love, hope, and a safe sanctuary to animals in need. Some of our volunteers transport, foster, feed, and train our rescued animals. Other volunteers help with organizing adoption events, paperwork, fundraising, creating flyers and various other marketing media to promote our organization.
